It is informed that M/s Rakshak Security Private Limited has been found lowest bidder, quoted rate of amount of Rs. 6,14,000/- per month as finalized by the Purchase Committee. The Purchase Committee has recommended that work for security services in KV-II campus may be given to the M/s Rakshak Security Private Limited for a period of three months at first instance w e f 01.08.2019 thereafter extension of term to the Security Agency will be given subsequently depending on their satisfactory performance. Accordingly, the proposal as finalised by the Purchase Committee has been approved by the BOM with following terms and conditions apart from the terms and conditions as per tender document:

- 1 The quoted rate of amount Rs. 6,14,000/- per month as finalized by the Purchase Committee shall remain unchanged during the period of contract under reference and that will be subject to actual attendance of workers deployed.
- 2 As per tender, total 42 personnel (38 Security Guards, 2 Security Officer and 2 Supervisors) will be deployed by the firm regularly without fail.
- 3 The firm will submit the affirmed and signed Agreement duly authenticated by the competent authority.
- 4 All information with respect to remitted amount of subscriptions such as EPF, ESI or any other mandatory remittance within the stipulated time supported with authentic documents will be furnished by the firm to the AOA office regularly.
- 5 The firm will submit the copy of Adhar Card in respect of each personnel in the AOA Office.
- 6 Three Walkie-talkies be provided to Security Guards posted at three Gates of KV-II and one for AOA Office for swift communication in order to maintain security and safety of the campus in a better manner.
- 7 The present Security Officer will not be changed unless it is permitted by President/ Vice President, AOA.
- 8 Security Guards will be properly dressed in the prescribed uniform duty duty hours.
- 9 AOA, KV-II reserves the right either to increase or decrease the number of Security Guards.
